## Do I pay GST?

GST is required on fees paid by NZ residents or NZ based companies. Where one of a number of applicants is a New Zealand resident or a New Zealand based company, GST is required.

Overseas residents or companies based overseas are not required to pay GST on fees.

## Methods of Payment

The principle methods of payment for all Office fees are: cash, cheque, credit card or bank draft. It is possible, by way of a prior arrangement with the Office, to pay all fees by direct debit.

Cheques and bank drafts are to be made payable to the 'Ministry of Economic Development'.

Overseas residents will need to pay by bank draft made out in NZ\$, or a cheque that can be drawn on a bank that has a branch in New Zealand.

N.B. The Intellectual Property Office is unable to accept payment in the form of direct deposits (direct credits) in to the Office's bank account.
