Review of Schedule of Costs for IPONZ Hearings

In IPONZ trade mark and patent proceedings the Commissioner may award costs to a party that the Commissioner considers reasonable. The Commissioner's standard practice is to order the unsuccessful party in proceedings to pay costs to the successful party in accordance with a schedule of costs.

IPONZ has carried out a review of its schedule of costs for trade mark and patent hearings, in collaboration with the Hearings Technical Focus Group and the IPONZ Assistant Commissioners. This review found that the schedule of costs for IPONZ hearings needs to change.

The purpose of this document

The purpose of this document is to provide people interested in the review of the hearings cost schedule with the proposed changes to patent hearings, and provide instructions on how you can have your say.

A Summary of Proposed Changes to the Hearings Schedule of Costs for Trade Marks is also available.

What changes are proposed?

The schedule of cost changes are set out in the tables below.

Preparing and filing Notice of Opposition/Application for Revocation ⁺ and Statement of Case	\$500	\$700
Preparing and filing counter-statement*	\$300	No change
Preparing and filing opponent's/applicant for revocation's evidence ⁺	\$800	\$1200
Receiving and perusing opponent's/applicant for revocation's evidence*	\$400	\$500
For preparing and filing applicant's/owner's evidence*	\$800	\$1200
Receiving and perusing applicant's/owner's evidence ⁺	\$400	\$500
For preparing and filing opponent's/applicant for revocation's evidence strictly in reply ⁺	\$200	\$500
Receiving and perusing opponent's/applicant for revocation's evidence strictly in reply*	\$100	\$200
Preparation of case for hearing ⁺ *	\$500	\$800
Attendance at hearing by counsel ⁺ *	\$180 per hour or \$810 per day (4.5 hours)	\$220 per hour or \$1210 per day (5.5 hours)
