### **Enhancements to the IPONZ Case Management Facility**

### 11 December 2015

The enhancements to the IPONZ case management facility effective as of 03 December 2015 are as follows:

Changes to visibility of hearings documents

IPONZ has made the following changes to the way documents are handled for hearings cases.

- 1. Documents filed in hearings cases will now automatically default to being visible to both parties only.
- 2. Documents will retain their original file names upon upload.
- 3. The case management facility will display the date on which documents were submitted.

New 'Confidential Evidence' document type for hearings

A new document type 'Confidential Evidence' has been added to identify confidential information submitted as part of a hearings case. Only IPONZ will be able to view these documents until the party who submitted them has confirmed to the Hearings Office that they have been served on the other side.

Only confidential evidence should be filed using this new document type.

Uploading documents to multiple hearings cases

Users can now upload documents to multiple hearings cases by entering all of the respective case numbers in the document upload screen.

Submitting applications for rectification of a trade mark

Users may now submit requests to rectify and/or correct the Register through the online case management facility.

Requests on Patent applications made open to public inspection

All Patent cases under the Patents Act 2013 which become open to public inspection will now have their linked request cases become open to public inspection as well. This change is retroactive, and will apply to all Patents and Patent Applications to which section 78 applies.

Request cases cannot be directly searched, but may be viewed by following the hyperlinks under 'Linked Case(s)' on a case Bibliographic page.

- If a patent or design application is submitted online over the Christmas New Year period (25 December 2015 to 5 January 2016), the details of the invention or design should not be publicly disclosed until after the official filing date (5 January 2016). If this invention or design is disclosed before 5 January 2016, then the patent or design may be invalid if granted or registered.

Your online applications will receive an official filing date of:

- 24 December 2015 if they are submitted no later than 11.59pm NZDT on 24 December 2015.
- 5 January 2016 if they are submitted between 25 December 2015 and 5 January 2016.

#### Changes to the visibility of hearings documents and new method of filing confidential evidence

#### November 16, 2015

IPONZ is planning to change the default visibility of all documents filed in hearings cases from 26 November 2015.

From this date, all documents filed in hearings cases will automatically default to being visible to both parties in the online case management facility. This gives parties the ability to look under the 'Documents' tab to see if their documents have successfully uploaded in real time.

In light of this change, we are also introducing a new document type, 'Confidential Evidence'.

Documents filed as 'Confidential Evidence' will only be visible to IPONZ until the party that filed them confirms with the Hearings Office that its confidential evidence has been served on the other side.

Only confidential evidence should be filed using this new document type.

Please be advised that these changes will undergo extensive testing over the next few weeks, after which we will provide further updates.



## Madrid Infographic for 2014

## 9 September 2015

IPONZ has updated its Madrid infographic to reflect 2014 International Trade Mark figures.

The infographic provides an overview of countries New Zealand businesses are choosing to expand into using the Madrid system.

Changes from 2013 are:

• The number of New Zealand businesses using the Madrid System has increased from 279 to 340 international applications;

- India has knocked the UK out of the top 10 designated countries;
- Books and Instructional Materials have fallen out of the top 5 classes, to be replaced by Entertainment, Sporting and Training Services. This is due to companies like Les Mills being high users of the Madrid system.

#### IPONZ has new branding

The Intellectual Property Office of New Zealand (IPONZ) and the Plant Variety Rights Office (PVR) will have a new look with the release of our new visual identity over the upcoming months.

From today, newly-generated certificates and official outgoing correspondence for Trade Marks, Patents, PCT, Designs and Plant Variety Rights will have the new visual identity. The email notifications you receive from the case management facility will also incorporate the new visual identity.

Our new visual identity is designed to show IPONZ's position within the wider Ministry of Business, Innovation and Employment (MBIE) family while providing IPONZ with a clean, crisp and easily recognisable stand-alone identity.

Over the upcoming months we will incorporate the new visual identity into other IPONZ publications, materials and the IPONZ website.

Update to filing a PCT national phase entry

IPONZ has updated the method of retrieving documents from WIPO when filing a PCT national phase entry application.

WIPO specifications will now be downloaded following the submission of the online application, instead of during the application process. Users will be able to preview these specifications via a link on the online application form.

The original specification or corrected specification held at WIPO will be downloaded without the search report or pamphlet.

If there have been amendments under articles 19 or 34, then these will be examined by IPONZ but they will not be part of the specifications that are automatically downloaded. Users can either provide these amendments at the time of application, or wait to respond to the examination report.

Notification of removal of agent following a change owner request

Currently when a change of owner is requested, this will automatically remove the previous agent from the case. The former agent will now receive a notification confirming their removal.

Publication date in Journal Excel report

The Excel spreadsheet of journal search results will now display the publication date of each application.

The PCT-EASY functionality of PCT-SAFE will be decommissioned as of 1 July 2015. This was announced in WIPO's <u>PCT</u> <u>Newsletter No. 04/2014</u>. WIPO's contemporary fully electronic filing system ePCT is the recommended alternative to PCT-EASY. Applicants are encouraged to move to ePCT-Filing at their earliest convenience.

From 1 July the New Zealand PCT Receiving Office (IPONZ) will no longer accept any correspondence in PCT-EASY format.

## **Uploading of New Zealand Patent Records**

Records of New Zealand patents/patent applications published from 1861 to 1879 and from 1891 to 1979, have now been digitised and uploaded into the IPONZ online patent system. The collection does not include patents published in the period 1880 to 1890, as patents from that era were not in a format that could be digitised economically.

Each entry is derived from:

- the abstract printed in the Patent Office Journal from 1912 to 1979 (POJ 1207),
- the "Supplements to the NZ Gazette" from 1890 to 1912, or
- earlier compilations published by order of the New Zealand Parliament of New Zealand patents issued between 1861 and 1879.

The patent records of this collection may be searched using the Search Patent/Search Patent Case(s) facility of the IPONZ online system. Please note that only a few data fields are populated in these older records. A case will not be found by a search involving a field for data that has not been entered.

We are presently digitising copies of the patent specifications for these records and these will be loaded into the system as readable pdf documents linked to the case record.
